Motivation Letter

Dear Students, Professors and Staff of RSU,

I am writing this motivation letter to formally apply for the position of
International Collaboration and Human Rights officer on the International Student
Association board. Firstly, to introduce myself: some of you might know me from
classes, others from trivia nights but most probably from my involvement in social and
academic societies. Throughout my years in RSU I have been an active and passive
member in many events, participated in Riga Run Club and was newly appointed
research coordinator of ASAIEC. Beyond my involvement in groups, I am committed to
supporting student involvement in social settings and improving the study process at
RSU. For this reason, I am petitioning myself for HR.

As an international student myself, coming from Portugal, South Africa, and Angola, and having grown up in Germany, I understand the struggles as an international student all too well. It is through dissecting cadavers, having a good laugh about the stench of formaldehyde and teaching others to intubate that I was able to cultivate a

community at RSU. My passion for community building started in high school, where I led extracurricular activities like Model United Nations (MUN), met people from various backgrounds and learned how to work efficiently as a team. Of course, teams do not always work as intended. During my MUN presidency there was a clash between a teacher and student in which I had to manage the situation by speaking to both parties seperately, and then together, to reach a common ground on which to continue the session. Settling disputes is a key job of the head of HR, and my ability to remain calm and settle conflict while maintaining good morale will be benefitial to the board.

Recently, I was able to speak to the previous HR, Beatriz Coelho and attend an ISA meeting to gain insight into the role. Longterm I want to assess any opportunities to increase integration of all RSU students.

Given these points, I believe my community building skills, experience in leadership roles and commitment towards supporting international students and student-led bodies are qualifications that make me an exceptional candidate for HR.
